<u>Screwfix Trade Apprentice 2016 – Competition Terms & Conditions</u>

- 1. The prize will be a fantastic trade starter bundle worth approximately £10,000, including a Google Nexus tablet with accessories, a Laptop (make and model to be confirmed) with accessories, a business software package, £5,000 to spend on Screwfix products, and an allowance to spend on career enhancing courses/workshops e.g. website design, business accounts and finance, specialist trade courses etc. Together with other prizes to a total prize value of £10,000.

The competition is open to all UK residents aged 16 years old and over who are enrolled in a college either in England, Wales, Scotland or Northern Ireland on an apprenticeship that includes on-the-job experience and off-the-job training, or a full time student, leading to a recognised qualification. Entrants can enter at any level of their studies. Entrants must be enrolled in a construction, planning and built environment related course or a Business Services Industry (e.g. Electrical and Plumbing) or an Engineering/Mechanical related course.
